Guest speaker: Dr. Robb Willer, Center for Advanced Study in Behavioral Sciences, UC Berkeley

Dr. Willer is an Associate Professor of Sociology and Psychology at UC, Berkeley, where is currently a fellow at the Center for Advanced Study in the Behavioral Sciences. A previous guest on CCL conference calls, he was co-author of "Apocalypse soon? Dire messages reduce belief in global warming by contradicting just-world beliefs." In a forthcoming paper, he examines the differences in moral views between Republicans and Democrats on big issues such as climate change and how understanding these differences is key to the messaging that resonates with various groups.

WHY 350?

Our Newsletter, 350PPM (parts per million concentration of carbon dioxide in the Earth's atmosphere) seeks to educate the public about the impending crisis of global warming and climate change. We must reduce greenhouse gas emissions and return the levels of CO₂ in the atmosphere to no more than 350 parts per million. It is only at these levels or below that the climate and environmental systems of the earth as we know them can be maintained. As a point of reference it was 1988 when the earth's atmosphere contained 350 PPM of CO₂.
